## Annual Payment Discount

Where the entire year's fees are paid in full by Friday, 7 February 2025, a 5% discount off the annual School Fees will be given. Please contact the Business Manager to discuss.

### Sibling Discount

The school offers a sibling discount to families with more than one child in the household enrolled at the school. The 2nd child receives a 20% discount of the tuition fee component, the 3rd child receives 40% discount and the 4th and subsequent children receive 100% discount.

### Lower Income Discount

A substantial tuition fee discount is available to low-to-middle income families who meet specific eligibility criteria established by DECD School Card Section and have School Card status approved. Families who believe they may be eligible should contact the school office / Business Manager to discuss the process.

### **Payment Plans**

Payment plans will be available for payments made on a weekly, fortnightly, monthly or quarterly basis. All payment plans are to be finalised by the end of the school year.

## School Building Fund
